Olympic Theatre Arts Position Description Board of Trustees

Board members are critically important to the effectiveness and efficiency of operations of Olympic Theatre Arts. The ability of board members to work together productively will determine the success or failure of the organization in accomplishing its mission. The three elements necessary for success are: authority, responsibility and accountability.

Responsibilities of a board member:

- Know the organization's mission, purposes, goals, policies, programs, services, strengths, and needs.
- **Attend** board meetings and participate in policy making.
- **Serve** in leadership positions or undertake special assignment willingly and when asked.
- ❖ Promote and represent OTA in the community...Board members must be willing to stand up and be counted regarding the mission of the organization and its accomplishments. This will include speaking at organizational or social events, visiting with public officials and contacting and encouraging potential supporting members of Olympic Theatre Arts.
- Support the organization financially. Board members are required to be supporting members of OTA annually, as well as their committed time and effort.
- ❖ Recruit possible board nominees and volunteers who can make significant contributions to the work of the board and the organization's progress.

Meetings:

- Prepare for and participate in board and committee meetings and activities.
- Ask timely and substantive questions, using Robert's rules of Order, at board and committee meetings consistent with conscience and convictions, while supporting the majority decision on issues by the board. Follow the media relations policy or the Board of Trustees.
- Suggest agenda items periodically for board and committee meetings to ensure that significant policy matters are addressed.
